"In 1955 the Soviet Union re-legalized abortion on the basis of women's rights. However, this fact is not widely known. In the absence of a feminist movement, how did the idea of women's rights to abortion emerge in an authoritarian society, decades before it appeared in the West? The answer is found in the history of the Soviet politics of reproduction after World War II, a devastation in which 27 million Soviet soldiers and civilians perished. This enormous loss of predominantly adult males posed a threat to economic recovery. In order to replace the dead, the Soviet Union introduced the 1944 Family Law based on the proposal submitted by Nikita S. Khrushchev. This extreme pronatalist policy encouraged men to father out-of-wedlock children and celebrated "Mother Heroines." However, *Replacing the Dead* argues that in the absence of serious commitment to supporting Soviet women who worked full-time, the policy actually did extensive collateral damage to gender relations and the welfare of women and children. *Replacing the Dead* finds the origin of the movement to improve women's reproductive environment in postwar social critique arising from women and Soviet professionals. Neither Stalin, nor Khrushchev allowed any major reform, but the movement did not die out. With relegalization and lack of contraception, an abortion culture grew among Soviet women. The model of socialist reproduction continues to set socialist and postsocialist countries apart. This history is a cautionary tale for today's Russia, as well as other countries that attempt to promote births"--

They have shown that framing has an effect on individual's behavior. A bonus pay is experienced as more friendly than being threatened to pay a fine. As we face today a financial crisis, a discussion about incentive contracts has been started immediately. It is claimed, that incentive contracts of bankers or so called "risk-takers" have been the driving force towards the crisis. The BaFin advises the financial branch to lower the share of incentive contracts among their employees. In order to cut the bonus payment a higher fixed-wage ought to be paid. Obviously bonus payments are meant to lead to higher levels of effort, but it might be a question of definition what effort means in the short and in the long run. Since fixed-wage labor contracts are characterized by weak performance incentives, one could consider incentive contracts as the best alternative, including explicit performance incentives. But this is rather a costly action. Taking the experimental findings of Fehr et al. (2002) into account one could claim that a fixed-wage contract does better on voluntary cooperation than incentive contracts, since the highest voluntary cooperation has been observed in the trust treatment. Recently several financial institutions lowered the bonus payments and therefore induced higher fixed wage-payments. I think, if a worker already receives a "high" wage in the sense of above average wage (depending on its definition), the bonus incentive might fail to lead in a higher intertemporal effort. It makes the worker act as a risk-neutral or even riskless worker. This may not lead to a profitable outcome in the long run and it might be more profitable to pay a higher fixed wage.
